### MAYOR'S OFFICE TO END DOMESTIC AND GENDER-BASED VIOLENCE (ENDGBV) TRAINING TEAM

The Training Team at the NYC Mayor's Office to End Domestic and Gender-Based Violence (ENDGBV) provides engaging, interactive training and technical assistance to support service providers in effectively identifying and responding to clients experiencing domestic and gender-based violence. ENDGBV tailors its trainings to meet organizational/agency staff needs. We also offer support to the providers we work with, helping to review and develop curricula, policies, protocols around domestic and gender-based violence. We are committed to working with each provider to make sure that the training(s) provided are informative, relevant, and fun.

##### ***What trainings does the Training Team offer?***

Our two foundational trainings, ***Identifying and Responding to Intimate Partner Violence and Domestic and Gender-Based Violence: Laying the Foundation***, suitable for all audiences.

##### ***How long are trainings?***

Trainings are 2 hours long.

##### ***Is the signature IPV training a mandatory training for all City and CBO employees?***

No. Check with your agency to see if you are mandated to attend this IPV training.

##### ***What types of Technical Assistance are available?***

- *Training and Curriculum Development:* Assistance with creating and updating existing agency curricula and trainings.
- *Develop and Review Policies and Protocols:* Assistance reviewing and developing current policies and protocols around domestic and gender-based violence.

##### ***How can my organization schedule trainings?***

## Training Logistics

### ***Is there a cost to facilitate trainings?***

All trainings are free of charge.

### ***Where are trainings held?***

We can accommodate in-person or virtual trainings. Virtual trainings are usually conducted over Teams. If requested, we may be able to use the agency's own virtual platform instead.

### ***When can trainings take place?***

Trainings are scheduled from Mon-Thurs, usually but not limited to 10am-12pm and 2pm-4pm.

### ***How far in advance do trainings need to be scheduled?***

Scheduling depends on availability. We recommend scheduling trainings at least 4 weeks in advance.

### ***Do you offer CLE, CNE, CME or CEU credit?***

Some trainings may be eligible for continued education credits **only** if the hosting agency is a CLE, CNE, CME or CEU provider. We **do not** provide certificates of completion.

### ***How many participants are allowed in each training?***

Trainings require a minimum of 10 participants. Agencies with fewer than 10 staff members are welcome to join trainings hosted by another agency that provides similar services. There is no participant maximum.

### ***What do we need for a virtual training?***

A computer with a camera and microphone is best. If you don't have access to a computer but do have a smartphone, the Teams or Zoom app allows you to do almost everything needed. We ask that participants avoid dialing-in to our trainings.

## Other Questions

### ***Who leads these trainings?***

Trainings are facilitated by one or two Training and Curriculum Specialists. The Specialists have years of experience in the field and provide expertise in the many intersections of IPV and Gender-Based Violence.

### ***What teaching methods are used during the trainings?***

The trainings are designed to be interactive. The Specialists are skilled facilitators and encourage participant engagement throughout the trainings. Trainings are designed to transfer knowledge into practice by allowing participants to use realistic case scenarios and role plays tailored to their workplace and roles. We also provide additional resources and materials at each of the trainings.
